3. The trust will arrange storage facility or warehouse for storing donated foods or purchased food before onward distribution to service users.
4. The trust to secure permission from the local government and the relevant officials to carry out fund-raising and needs assessment.
5. The trust will ensure thorough operational management to ensure accountability, transparency and record-keeping and operations monitoring and control.

6. The trust to ensure that fundraising, financial support and other in kind support is achieved in a timely fashion; so as to enable sustainability and the continued development, growth and expansion of the trust.
